**Semester exemption application requirements and conditions:**

- The student must be enrolled in the Marching Band, Color Guard, Drumline, Pep Squad, Dance Production, or Aerobics\* course for the entire semester.
- The student must complete and submit this application, including student, parent and teacher/advisor signatures.
- Application form must be submitted during the registration process or no later than the first 30 days of the semester requested.
- Upon approval, this physical education exemption goes into effect for *this semester only*. A new application must be submitted for subsequent semesters.
- A Marching Band, Color Guard, Drumline, Pep Squad, Dance Production, or Aerobics\* member who quits or is dropped from the course is required to return to physical education class on the following day. Failure to report to class immediately will be treated as an unexcused absence/truancy. In addition, continued failure to do so will result in a W/F and loss of credit.
- All grade 9 students, including those with approved physical education exemptions, are required to complete the State-mandated Physical Fitness Test, given in the Spring.
- Elective credit will be earned upon successful completion of the semester course.

\* NOTE: Aerobics Exemption is only available for grades 10 - 12 and Physical Education Course 2.
